 plaza, with final opinions being divided as to whether creating a downtown plaza was a
 good idea or not.
- *Tyler* Once LEDC has formally approved the Tyler proposal at its 1/19 board meeting, the Coordinator will forward the proposal to Ms. James, and request guidance for moving the process forward, and getting the proposal signed.

Administrative

- *LAB overview document* Ms. Hughes and Mr. Patterson created a preliminary draft overview of Arts Board activities and description. The Coordinator will update and present at the next board meeting.
- Prospective board members It would be useful for LAB to include a realtor. Ms.
 Hughes suggested a neighbor as a possible candidate. Lansdowne Court resident

 LEDC mailing lists, will have the search listed in various local papers via the Borough,
 and will compile job descriptions for both the board and for board members.

Ms. Winters agreed to read and review board minutes, Ms. Hughes and Mr. Patterson agreed to work on the BC overview document (see above/below), and Ms. Halsey asked that Mrs. Coates work on the upcoming gallery show postcard with Ms. Weedon.
