Budget

The board reviewed a draft budget for 2017. Overall, the group agreed that gallery events and activities are going well, and that now is the time for LAB to propose goals for moving forward. The budget to include side by side overview of creative placemaking activities, and 20*20 House activities. Ms. Halsey agreed to approach Councilperson Robert Radich to discuss the budget with the board, prior to submitting the budget to Borough Council. It is hoped that Councilperson Radich will be able to assist with how to address the Board's concerns about building maintenance, repairs, etc, in the 2017 budget.

Building Usage

LAB votes to invite LEDC to consider leasing part of the 20*20 House. In order to have the building occupied, of course, it would need to be inspected. Ms. Halsey will meet with LEDC chair Ellen Lustgarten to help move the rental issue forward. The board discussed the significance of the borough's being willing to collaborate with local organizations, such as LEDC.

Rachee Fagg and the Coordinator have been discussing the library using the building for a gathering of knitters on October 22, immediately prior to the Elisabeth Nickles' opening. Ms. Fagg has also been in discussion about doing a story slam event.

Ms. Winter suggested that perhaps MFA thesis exhibitions might occur at the 20*20 House. Ms. Halsey encouraged Ms. Winters to share more about this idea if she discovers significant interest in the issue.

Creative Placemaking

The Coordinator and Debbie Brodeur of LEDC will be meeting with Jeffrey Doshna, the director of the Planning and Community Development program at Temple University's Tyler School of Art. Updates to follow.
